Ian Grant advised that this draft addresses all of the arts and provides the Shoalhaven Arts Board with a future framework document. The Strategic Plan will market strongly beyond the Region so it can be viewed by the rest of Australia to make the Region an arts destination.

Alison Chaim advised this could be an interim strategic plan and a working document. It was created by a working party with a strong vision and value.

Alison Chaim and Ian Grant suggested that another option would be to hire a professional strategic planner as we don't have an adequate strategic plan.

Ian Grant and Alison Chaim have experience in the field and together have offered to develop a strategic plan over 6 months.

Jane Lewis presented a visual overview model and requested that the Draft Strategic Plan document in discussion, be viewed by staff and the Director of Corporate and Community Services. Members must recognise that there are already strategic documents in place and the budgets as part of the DPOP to deliver these. Jane Lewis also advised that the detail of the Shoalhaven Arts Board Terms of References needs to be involved and developed by the Board for the Strategic Plan for Libraries, Arts Centre and Shoalhaven Entertainment Centre (e.g. Arts Foundation, Awards and Recognition, Sponsorship, Arts Board Grants, Grant Application Panel, Art Acquisition).

It was decided to amalgamate ideas and frameworks as a working party. Clr Baptist praised the Shoalhaven Arts Board for their very strong heart for change and intellectual capacity to achieve.

A Project Plan needs to be developed collaboratively including the key milestones and engagement process (a Project Control Group).

Clr Baptist advised he is willing to be included as part of a peer panel.

Purpose / Summary

To advise the Shoalhaven Arts Board members on the recommendations of the Shoalhaven Arts Board Grants Sub-Committee regarding the awarding of the 2016/17 Shoalhaven Arts Board Grants

Recommendation

That the following Shoalhaven Arts Board grants be awarded:

- 1. \$7,000 Callala Bay Progress Association for their public art project 'Traditional Log Installation'
- 2. The \$5,000 grants be awarded following the update provided by the Manager Arts and Culture at the meeting as outlined in the discussion in this report

Options

1. Adopt the Recommendation as printed and discussed

<u>Implications:</u> The Shoalhaven Arts Board support local arts organisations through the grants program and provide opportunities for the development and delivery of interesting arts based activities in the region.

2. The Shoalhaven Arts Board provide an alternate resolution

Implications: unknown at this stage.

Background

The Shoalhaven Arts Board have an annual allocation of funds for the development of arts in the area. In 2015 the Board reviewed the grant program and decided on a reallocation of funds, to help fund significant projects and artistic development. The 2015/16 grants were awarded to Elyssa Sykes-Smith for a piece of public art that is site specific to the Shoalhaven Entertainment Centre, a mural at Moona-Moona creek as a collaborative artwork between Clayton Campion and the Jervis Bay Maritime Museum and assisting Jervis Bay and Basin Arts with the funding required for the closing event at the 2016 See-Change Festival.

The 2016-17 grants programs was kept as three grants of significance, but the emphasis on collaborative projects was removed from the \$5,000 grant project and those grants were instead focussed on Developing the Arts. All applicants were asked to attend one (1) of three (3) workshops held throughout the application period to ensure the applications that were received were of a higher quality than previously and that all applicants properly understood the purpose of the grants.



2016/17 Grants

Following the application period and associated workshops, four (4) applications were received for the Arts Board Grants. The Arts Board Grants Sub-Committee met and discussed the applications. The single applicant for the \$10,000 public art grant was deemed to be a suitable applicant with a strong proposal that met the aims of the grants and the recommendation has been made that the \$7,000 asked for be awarded. The applicant did not request the full amount of funding available.

There were three (3) applicants for the \$5,000 'Developing the Arts' grants (2 x grants available), and the sub-committee felt that while two (2) of the applications had merit there was not enough information in the submitted paperwork to be confident in awarding either applicant the money requested at this stage.

The sub-committee requested that the Manager – Arts and Culture, seek additional information on points of concern from the two (2) applicants prior to developing a recommendation. This information is in the process of being sought, but was not available at the time of writing the report. A verbal update on the status of the grants and the recommendation will be provided at the meeting.

The remaining application was not deemed suitable as it did not have a strong connection with Developing a Sense of Place – which is the Key theme of the grants program.

Community Engagement

The Shoalhaven Arts Board grants provide funding for a range of individual artists and art organisations working within the Shoalhaven, ensuring that the community benefit from increased access to and participation in the arts and that the arts are of a high standard.

Financial Implications

The Shoalhaven Arts Board Grants are funded to an amount of \$20,000 in the current Arts and Culture Unit budget.

- The work *By the Pool, Meroo NSW* by Leonard Long be acquired by the Regional Gallery Collection for the cost of \$1,100 funded from Arts & Culture budget (Job Number 21596 / 10729)
- 2. The work *W.Wind Gale* by Samuel Elyard be accepted as a donation into the Regional Gallery Collection

Options

1. Adopt the Recommendation as printed

<u>Implications:</u> The Shoalhaven City Art Collections continues to grow and be a robust collection with strong representation of works and artists of local significance. There are funds available in the Arts & Culture Unit budget for the acquisition of the work, the ongoing insurance, conversation and preservation of the works is covered in the annual operations budget for the Arts Centre.

2. The Shoalhaven Arts Board provide an alternate resolution

Implications: unknown at this stage.

Background

Council has recently been offered two (2) artworks for consideration and possible inclusion in the Shoalhaven City Council Art Collection. The Arts Board Art Acquisition Sub Committee has reviewed these offers. The following information is presented to the Board for consideration along with the Sub Committees recommendation which support the acquisition / acceptance of the two (2) works by Council.



1. Offer to Acquire work by Leonard Long




By the Pool, Meroo NSW Leonard Long c. 1950s

The work was purchased directly from the artist in the 1950s and kept within the family, being sold to another family member in the 1970s. The owners of the work are now deceased and the Estate have approached the Shoalhaven Arts Board with the offer to purchase the work for \$1,100.

The proposed acquisition meets the criteria of the Shoalhaven City Council Art Collection (POL 14/23) under section 3.1.6 under the following considerations:

- Local Significance
- Historical and/or cultural value
- The artworks' current and future relevance to the Collection
- Significance of the artist

As the Shoalhaven City Art Collection already holds a number of works by Leonard Long, this acquisition is in keeping with an established precedence and known significance of this artist to the region and collection.





Wind Gale 3pm 6Jun '70 Samuel Elyard

The work was originally part of the Halloran Collection and was gifted to the owner's mother as part of a birthday present. Following the death of her mother the donor is now keen for the work to stay in the Shoalhaven and has offered the work as a donation to the City Art Collection.

The proposed acquisition meet the criteria of the Shoalhaven City Council Art Collection (POL 14/23) under section 3.1.6 under the following considerations:

- Local Significance
- Historical and/or cultural value
- The artworks' current and future relevance to the Collection
- Significance of the artist

As the Shoalhaven City Council Art Collection already holds a number of works by Samuel Elyard, this acquisition is in keeping with an established precedence and known significance of this artist to the region and collection.

Community Engagement

The Shoalhaven City Arts Centre provides a broad range of local and nationally significant exhibitions to showcase a cross section of artwork and media. It is important that our collection reflects the range of artists and art work produced within the Shoalhaven, and also provides an aspirational element to inspire artists and community members. These two works have a strong provenance linking them to Nowra, and are by artists already well represented within the collection.

Financial Implications

The cost of the acquisition is covered in the existing Art Acquisition budget (Job Number 21596 / 10729) and included in the current year's acquisition budget. In the current financial year the Arts Board have spent \$2,800 from the annual allocation of \$6,119 for the purchase of a work by Randall Sinnamon. There is sufficient funding to purchase the Leonard Long work.

Neither of the works are currently valued, however other works in the collection suggest that an approximate value of the Samuel Elyard work would be less than \$1000 and the approximate value of the Leonard Long work would be around \$2,500. Valuation and conservation / preservation of both works would be required, however these costs are part of the overall collection management budgets and operating expenditure of the Arts Centre.
