

Good afternoon,

I spoke with [redacted] on Friday who was kind enough to allow me to get my application in for yesterday 24th January Monday however I have been unable to as a result of my own housing issues at the moment and so currently have a few pressing issues I am dealing with.

The Homeless issue is one I have always had an immense passion for. I relocated here approx 6 years ago from Potts Point as a result of rents increasing.

In May 2018 I founded Socks n Jocks on a shoestring budget, the Illawarra/South Coast community is asked to donate a new pair of socks or jocks for the homeless.

Each year the aim is to bring local business and community together in support of those who, for reasons far beyond their control, are homeless and will experience the razor edge of winter.

It will be in its 5th year this 2022, I have no idea how I will pull this off, a lot of the time I am struggling with my own accommodation or unemployment issues, so I understand the struggle from a personal point of view.

Below are some links where you will find out more about me in the hope you could consider my application. Apologies I am not able to complete the appropriate form and this is a little easier for me to copy and paste some links with providing some answers.

I have to get ready for work now as I start at 4pm and have to drive to Kiama from Bomaderry. I am trying to get some bond money together however do not have enough hours. 3. Why would you like to join the Shoalhaven Homelessness Task Force?

Over the past 3 years I have been doing research into developing a proposal for a National Cooperative Housing Scheme including a pilot scheme run by the Shoalhaven City Council. That is why I need to be on the Homeless Task Force to get the proposal up and running. I'm 81 now, still plenty of energy but need to be part of a team that has contacts and power to keep the momentum going. The Labor Party have announced a \$10B plan to deal with the homeless crisis as part of their election manifesto. This is sure to be matched by the Liberal Coalition and so it would be timely to have an advanced plan on the table for all that money swishing around looking for a home! My proposal on a National basis calls, amongst other things, for the setting up of a National Housing Cooperative Group overseeing Regional and State entities. The Shoalhaven City Council could be at the forefront of this move by being first in with a solid and well presented proposal.

I note the minutes of the Taskforce meeting 14 October 2021 mention preparations for a National Housing Plan at page 42. Also, in the same report at page 15 it mentions of the need to look at different models such as equity and covenant housing. The proposal I have been working on fits in well with a lot of the work already undertaken by the present and previous Homelessness Taskforce.

On a local basis I envisage the setting up of overnight shelter schemes at various townships for itinerate homeless people. Also, a rental assistance scheme for existing caravan park residents to protect them from excessive site fee increases and bullying by Caravan and Manufactured Home Estate (MHE) owners which seems to be on the increase with the gentrification of such parks. Again, I see the Taskforce as being the ideal place to pursue and advance these ideas.

4. I will bring the following skills/experience and/or attributes to the Taskforce.

I spent 23 years in Qantas as an Airport Manager at various international airports and was then recruited by the International Air Transport Association (IATA) to head up the industries Taskforce aimed at reducing the increasingly alarming rate of lost baggage by airlines. Working out of both Geneva and Montreal, I conducted workshops and industry conventions at numerous airports worldwide and created a committee network representing some 450 international airport authorities. During this period we halved the lost baggage rate.

This experience instilled in me the value of the properly coordinated multidisciplinary approach rather than any individual effort. I can see the value of such coordination being needed to harness the energy of all the diverse array of excellent and mainly voluntary workers that are presently involved in a variety of ways helping with the present homelessness crisis.

I was previously the Regional Manager, Far South Coast for the park resident's association, ARPRA, but had to relinquish this post to focus on problems closer to home in my role as Chairman of the Milton Valley Holiday Park.

5.If you have personally experienced homelessness in the Shoalhaven Local Government Area, please provide a brief description of your experience.

I am presently part of the itinerant homeless community moving up and down the South Coast. I have a small motorhome and spend only a few days in any one location to avoid attention from various local authorities. I was originally resident in the Milton Valley Holiday Park but some 8 months ago I moved out of there for my own safety following advice from the local police. I was and still am the Chairman of the Resident Committee for that park but after some 4 years of continual Tribunal actions over excessive site fee increases and attempts to evict one of the other committee members, park management have made life very difficult for me to the extent I now have genuine fears for my own safety and have moved away from the park. For various reasons I'm unable to sell the van & annex that I own and am still paying site fees even though I don't spend much time there anymore. I have to return intermittently though as I'm still involved in my advocacy role for some of the residents as well as still being involved in a Tribunal appeal against orders for an excessive site fee increase last year. This may well take another 3 months to resolve but once that is over then I will resign as Chairman of the Residents Committee and hand the reins over to the park resident's association, ARPRA.



3. Why would you like to join the Shoalhaven Homelessness Taskforce?

I have a strong passion for social equality and to bring an end to homelessness around the world. I am originally from Argentina (South America) and left my country in 1990 to move to the USA, while living in Argentina there was no homelessness in their society, but less than 10 years after I left when I returned to see my relatives there I could not believe my eyes to see homeless people begging, walking around Buenos Aires, and settling under carton boxes to sleep at night in street corners. It was a major shock for me, as I had seen the tremendous negative impact to society from having a large homeless population while living in the USA. I participated in many groups in San Francisco to provide assistance to the homeless in the form of food, referrals for medical services, referrals for accommodation, etc. I never thought I'd see that happening in Argentina, but this "cancer" to our modern societies is there too. I moved to Australia in 1999, I love Australia and its people and that's why I made it my home now. We live in a rich country, within a diverse multicultural and mostly harmonious society, but we still battle the homelessness "cancer" in our country. I have only been able to make a small difference to this problem by collecting donations to provide to our local Homeless Hub, so I hope that joining the Shoalhaven Homelessness Taskforce will allow me to channel my passion better and make a significant difference to the lives of those who are homeless and suffering in the Shoalhaven, and perhaps set an example for other council areas to emulate.

I have not experienced homelessness in the Shoalhaven area, or anywhere else, however while in Sydney and working for a major Australian investment bank I joined a Homelessness Awareness group and we participated in activities to provide us with a better understanding of the challenges and risks people who are suffering with homelessness face day to day. One of those activities was to simulate for 24 hours to be living as a homeless person in Sydney, including getting and eating food out on a park, and sleeping out in the open using just a swag. That experience was mind opening, even though we all knew we would return to our comfortable lives and homes at the end of the 24 hours activity, we shared the activity with people who were living homeless at that time in Sydney. We were lucky that the winter night when we slept out was not too cold, but we all knew the individuals who were truly homeless and shared that night with would repeat that night after night, and many of them were just people like any of us. We gain understanding and more importantly a lot of empathy from the experience, and planted inside each of us the desire to do something to remove that problem from our society. It has been a few years since I participated in that experience, but the memories are still fresh in my mind as if it had been yesterday. I retired in June 2021, I now have the time, skills and certainly the passion to do something about it, and hope that being part of the Shoalhaven Homelessness Taskforce will allow me to do that.

Homelessness is my passion, and I believe that we all need to work towards a present and future in which housing is understood and respected as a basic human right.

I am currently working as an Assistance with Care and Housing Coordinator with 'Age Matters' - a non-for profit organisation which supports older persons within the Illawarra-Shoalhaven who are experiencing, or are at risk of experiencing homelessness.

This role, and the stories of the people that I work alongside, have fueled this passion further. Currently, access to appropriate and affordable housing within the Shoalhaven region is virtually non-existent. This is placing the wellbeing and safety of thousands of individuals at risk - day in and day out.



During my career in the ADF I have experienced a variety of jobs and I have developed broad experience working with a range of people from diverse backgrounds.


