The Shoalhaven Traffic Committee is a technical review committee, not a committee of Council under the Local Government Act 1993. Transport for NSW (TfNSW) has delegated certain powers to Council under the Transport Administration Act 1988 (Section 50). A condition of this delegation is that Council must take into account the Traffic Committee recommendations.

There are four formal members of the Traffic Committee, *each of whom has a single vote only*. The members are representatives from:

- NSW Police Force
- TfNSW
- Shoalhaven City Council
- Local State Member of Parliament (for the location of the issue to be voted upon)

If TfNSW or NSW Police Force disagrees with any Traffic Committee recommendation, or Council's resolution (on any Traffic Committee recommendation), they may lodge an appeal with the Regional Traffic Committee for determination. The appeal must be lodged in writing within 14 days of the date of notification in writing. Any action relative to any issue under appeal must cease until the matter is determined. The Regional Traffic Committee is chaired by an independent chairperson and submissions and representations are welcomed from all interested parties.

Council cannot amend a Traffic Committee recommendation. The Council can only: adopt the Traffic Committee recommendation; not adopt the Traffic Committee recommendation, or request the Traffic Committee reconsider the issue.

Reason for Report:

The reason for this report is to seek Shoalhaven Traffic Committee approval for the proposed signage and linemarking restrictions associated with the road rehabilitation along Illaroo Road, North Nowra as per Plan No. D25/190486.

Background

As part of the joint funded project between the Australian and NSW Government, Shoalhaven City Council have made significant progress on the detailed design for the proposed road rehabilitation along Illaroo Road, including the associated signage and linemarking. This project aims to enhance road safety, improve traffic flow, and ensure better connectivity for the local community.

Details of Submission

The following changes to road conditions are proposed:

- 'Give Way' restrictions at the intersection of Illaroo Road and Karana Drive, Bangalee
- Double barrier linemarking (BL2) along Illaroo Road from Karana Drive, Bangalee to Browns Mountain Road, Tapitallee
- Edge Line linemarking (EL1) along Illaroo Road from Karana Drive, Bangalee to Browns Mountain Road, Tapitallee
- As part of the project, the road will undergo new pavement, resealing, drainage improvements, and residential driveway adjustments.

Consultation

Consultation was undertaken with adjacent residents, businesses, stakeholders, Budgong Community Group Inc and Cambewarra Residents & Ratepayers Association and closed on 28 April 2025. Six submissions were received. Three were in favour of the proposal, and three provided a 'mixed' response. The 'mixed' responses outlined that they'd like to see the existing 'temporary' (due to poor pavement conditions) 60 km/h speed zone retained instead of reverting back to the previous permanent 80km/h. These residents were advised that speed zone reviews fall under the jurisdiction of Transport for NSW (TfNSW) and that such requests can be made directly to TfNSW.

Risk Implications

The proposal aims to improve road conditions, enhance traffic flow, and increase safety for all users by implementing comprehensive rehabilitation measures, including resurfacing the section of road, upgrading drainage, signage, and linemarking.


Financial Implications

The road rehabilitation, linemarking and signage for this proposal are funded by the Australian and NSW Government through Disaster Recovery Funding Arrangements and NSW Infrastructure Betterment Fund. However, Council will be responsible for the ongoing maintenance of these assets.







Reason for Report:

The reason for this report is to seek Shoalhaven Traffic Committee approval for the proposed TriCallala Triathlon Festival 2025 Traffic Management Plan (TMP) and Traffic Guidance Scheme (TGS) as per plan No. D25/192738 and D25/192740.

Recommendation

That

1. The Chief Executive Officer (Director City Services) be advised that the Shoalhaven Traffic Committee has no objection to the proposed Traffic Management Plan (TMP) and Traffic Guidance Scheme (TGS) as per plan No. D25/192738 and D25/192740; subject to the following:
 - a. All dimensions for travel/lane widths meeting the minimum requirements as per *TS 05492*.
2. The recommendation be approved by the Director City Services under delegated authority from Shoalhaven City Council - refer MIN21.411

Background

Elite Energy's TriCallala Triathlon Festival is proposed to take place on Saturday 13 December 2025 at Callala Beach Community Hall with some changed traffic conditions. This event is classified as a 'Class 2' event as per Guide to Traffic and Transport Management for Special Events, which require Local Traffic Committee endorsement. A TMP and TGS is attached for the Committee's consideration.

Details of Submission

1. Road Closures

The following road closures/restrictions (with exceptions for emergency and official event vehicles) are requested for the safe and timely setup, use and pack-up of the transition area, the finish chute, finish arch and crowd control barricades:

1. Closure of the **Callala Beach Community Centre Car Park** (emergency & official vehicles exempt) from **12:00pm** 10 December 2025 through to **6:00pm** 13 December 2025.

The following road closures (with exceptions for emergency, event official vehicles and local residents) are requested for **13 December 2025** for the safety of competitors and the public during the running of the triathlons & miniman events:-

1. Road Closure of **Forest Rd** from **Princess Hwy** to **Callala Bay Rd** from **8:00am – 11:00am** (approx.) 13 December 2025.
2. Road Closure of **Callala Beach Rd** from **Forest Rd** to **Emmett St** from **8:00am – 12:30pm** (approx.) 13 December 2025.
3. Road Closure of **Centre St** from **Quay Rd** to **King George St**, **8:00am – 1:00pm** (approx.) 13 December 2025.
4. Road Closure of **Quay Rd** from **Callala Beach Rd** to **Sir Henry Cres**, **8:00am – 1:00pm** (approx.) **13 December 2025**.
5. **Forest Rd, Callala Beach Rd** wherever the posted speed limit exceeds 60kmh. Speed reduction to 60kmh to be implemented.

Note: There will be periods during the triathlons when there will be no competitors on Centre St & Quay Rd. Residents and people requiring access to these streets will, under the direction of traffic controllers, be allowed to travel along Centre St & Quay Rd during these times.

2. Event Infrastructure

NSW Ambulance, Police and Fire Brigade: Emergency access lanes have been designated to facilitate the entry of emergency vehicles into the areas where road closures are in effect.

Medical: There are medical personnel onsite for the duration of the event, at Callala Beach Community Hall, Quay Road.

Port-A-Loos: There will be an appropriate number of port-a-loos and 2 accessible toilets in Callala Beach Community Hall, Quay Road.

Cleaning/Disposal: There will be wheelie bins and skips positioned at various locations at the festival site. During the event there will be waste staff servicing the festival area of rubbish.

Barricades: Accredited Traffic Controllers will install road closure barriers to ensure the safety of the closed-off roads.

3. Transportation, Awareness of Event and Access

Public Transport: The event organisers will inform public transport companies about the event, to allow for any necessary adjustments to their regular routes, ensuring safety and minimal delays.

Parking: There is no dedicated on-site parking available for this event. Competitors and spectators are advised to park in surrounding streets, ensuring they are not blocking driveways and they do not park illegally on corners.

Access/Awareness: A notice will be delivered to the letterboxes of residents and businesses in and around Callala Beach, Callala Bay and Myola, providing them with at least 21 days' notice. The notice will contain information regarding road restrictions and alternative routes. Resident access will be ensured throughout the day, if it is safe to do so. It is advised that all traffic yield to cyclists and adhere to designated speed limits.

Risk Implications

1. Parking Limitations and Potential Congestion

The event is proposed to take place in the middle of December, when there is typically a high volume of day trippers and visitors to the region. With the higher

vehicle and pedestrian demand and combination of event patrons, there is the potential for traffic flow issues, parking constraints and delays throughout Callala.

2. Local Business and Resident Impact:

Road closures and increased traffic may make it challenging for customers to reach businesses, and residents may experience noise disturbances, limited access to their properties, or inconvenience due to traffic restrictions.

3. Lane Widths:

To reduce safety concerns regarding unsafe lane widths, the TGS is to be implemented in accordance with TS 05492 - Traffic control at work sites” 20.346 | Issue No.6.1 28 February 2022 Transport for NSW with and the subsequently listed considerations:

- Clause 4.3.2 on Lane Widths: The minimum width for lanes carrying traffic around, past or through a work site must be in accordance with Table 4-2.
- Lane widths should also consider accommodating the turn paths of large vehicles expected to negotiate the work site as per Clause 4.4.5 for Heavy Vehicles.
- Where existing lane widths are narrower than those specified in the table above, the lane widths may be maintained. However, the TMP must document provisions for turning paths, sight distances and vulnerable road users.
- Where fixed vertical obstructions such as fences or safety barriers are restricting the available shoulder width, consideration should be given to increasing lane widths to accommodate larger vehicles.

Financial Implications

This event is funded by the event organiser (Elite Energy Pty Ltd) and there will be no financial implications to Council.

Mission

This document – Traffic Management Plan (TMP) aims to provide a plan for vehicular traffic and pedestrian control measures to assist in delivering safe logistical support of TriCallala Triathlon Festival event planned to take place Callala Beach Community Hall, Quay Street on Saturday, 13th December 2025. The underlining objective is to minimise safety conflicts between vehicles and pedestrians and disruption to normal vehicular and pedestrian traffic on all approaches to Callala Beach Community Hall, Quay Street.

The objectives of this TMP are:

- To provide a high level description of the various traffic management elements needed to make the event a success
- Ensure effective separation between event patrons and participants from vehicular traffic
- To provide a framework for each agency to use to develop their own lower level plans
- To serve as the key document that is agreed to by all parties and is the final approval to conduct the event.
- Minimise impact on non-event community and emergency services

Situation Analysis

On Saturday 13th December 2025, there will be TriCallala Triathlon Festival event held on Callala Beach Community Hall, Quay Street that will require altered traffic arrangements.

EVENT DETAILS

The **Tri Callala Triathlon Festival**, to be held on **Saturday 13th December 2025**. Saturday **Morning** event will include a **Standard Triathlon, Aquabike, Sprint Triathlon, Super Sprint Triathlon, Tri Kids 10-11yrs and Tri Kids 7-9yrs**.

The festival will be conducted by **Elite Energy Pty Ltd** and approved, sanctioned & insured by the national governing body, Triathlon Australia. **All** athletes **MUST** abide by the current rules & regulations of Triathlon Australia endorsed by the International Triathlon Union (ITU).

EVENT and COURSE DESCRIPTIONS

Transition Area, Finish Chute, and Finish Line

The Events will start on the beach behind the Community Centre Car Park off Centre St. The transition area for the events will be set up in the Community Centre Car Park and adjacent reserve. The finish chute and finish arch for the events will be set up on the council verge (nature strip) in front of the Community Centre on **Quay Rd**. Setup of the Transition & Finish Line will be required to start from 9:00am on **Thursday, 11th December 2025**.

Saturday 13th December 2025

Standard Triathlon & Aquabike

(8:00 – 12:00 Saturday 13th December 2025)

The Olympic Distance Triathlon will consist of a 1.5km swim, 40km bike leg which will head out along Callala Beach Road, turning west along Forest Rd to a turnaround point near Butterfly Rd. Cyclists will then head east, to another turn located on Forest Rd, located west of Callala Bay Rd, before returning to Quay Rd. (Bike leg for Standard athletes will consist of 2 laps). This is followed by a 10km run leg out to Myola and back. The event will commence and finishing at the Quay Rd/Centre St. Event area. (See course map for details).

The Aquabike will consist of a 1.5km swim, 40km bike leg which sees riders complete the above course.

Sprint Triathlon

(09:15 – 11.30 Saturday 13th December 2025)

The Sprint Triathlon event will consist of a 750m swim, 20km bike leg which will head out along Callala Beach Road, turning west along Forest Rd to a turnaround point near Butterfly Rd. Cyclists will then head east, to another turn located on Forest Rd, located west of Callala Bay Rd, before returning to the transition area. Sprint is finished with a 5km run leg all commencing and finishing at the Quay Rd/Centre St event area. (See course map for details).

Super Sprint Triathlon

(10:45 – 11:45 Saturday 13th December 2025)

The Super Sprint Triathlon event will consist of a 200m swim, 8km bike leg which will head out along Callala Beach Rd, turning before the Forest Rd intersection and returning to transition, followed by a 2km run leg all commencing and finishing at the Quay Rd/Centre St event area. (See course map for details).

Tri Kids – 10-12yrs

(11:15 – 12:00 Saturday 13th December 2025)

The 10-12yr Tri Kids will consist of a 100m swim, 6km bike leg which will head out to turn on Callala Beach Rd, south of the Queen Mary St intersection for 2 laps and 1km run leg all commencing and finishing at the Quay Rd/Centre St event area. (See course map for details).

Tri Kids – 7-9yrs

(11:30 – 12:00 Saturday 13th December 2025)

The 7-9yr Tri Kids will consist of a 50m swim, 3km bike leg which will head out to turn on Callala Beach Rd, south of the Queen Mary St intersection and 500m run leg all commencing and finishing at the Quay Rd/Centre St event area. (See course map for details).

IGA 2km Santa Dash

(1:00pm – 1:10pm Saturday 13th December 2025)

The 2km Santa Dash will start at the Quay Rd/Centre St event area with entrants running south-west on Quay Rd, turning 1km from the start and finishing at the Quay Rd/Centre St event area.

Note: That the swim start will be staggered (wave) start over approximately 15 minutes so that when the competitors get onto their bikes they are not on the road in a big bunch

Traffic Control measures included in this document is a result of consultation undertaken by Elite Energy, Shoalhaven City Council, NSW Police & RMS (if required).

TRAFFIC ARRANGEMENTS

Traffic control measures include simple hard and soft road closures, use of traffic control devices (traffic signs) to warn motorist of the changes in traffic conditions. It is noted that per NSW

Workplace Health & Safety (WHS) law the Event Organiser – Elite Energy and Landowners – Shoalhaven City Council, TfNSW (if required), bear individual and shared risks related to the safety of event patrons and motorist. Elite Energy is identified as being responsible for event related safety risks which are associated with non-transferable WHS statute-posed obligations and Common Law Duty of Care provisions. In this context, Elite Energy should continue to actively consult and take all reasonable measures to practically exercise their duty of care obligations.

Risk Assessment

Part 8 of this document includes the completed risk assessment for the event.

Execution

General Outline

The event requires highly coordinated efforts from a number of agencies:

Elite Energy

- Co-ordinates the logistics for holding the event, Venue Management / Event Production / Stage Management / Marshalling / Programming
- Arranges advertising for road closure locations, times, other traffic disruptions / delays and alternative route information in the Local News paper if required.
- Prepares the Traffic Management Plan
- Provides traffic information signposting as identified in the TMP and associated Traffic Control Plan(s) (TGS).
- Provides resources and traffic management infrastructure for traffic control and road closures as identified in the TMP
- Monitors traffic on all roads approaching Callala Beach Community Hall, Quay Street to minimise traffic congestion on the day.

A Risk Management approach shall be an integral part of the planning for TriCallala Triathlon Festival event. The risk, identification, assessment and control process is a legal obligation (as per the NSW Workplace Health and Safety Act and Regulation) and should be compliant with AS/NZS ISO 31000:2018. The event organiser is responsible for the management of risks arising from TriCallala Triathlon Festival.

It shall be noted that Traffic Management Plan (TMP) and particularly Traffic Control Plans (TGS) are seen as risk control measures, but alone they cannot substitute and AS/NZS ISO 31000:2018 – compliant and detailed event Risk Assessment.

Barricade Locations and Road Closure Times

Refer to Part 2

Traffic Control

- All traffic control including the placement and removal of barricades and/or regulation of traffic is to be carried out in accordance with the requirements of the approved Traffic Guidance Scheme and is to be undertaken by either Police or Traffic Controllers appropriately trained in accordance with the requirements of AS1742.3 and giving consideration to the TfNSW Traffic Control at Worksites Manual.
- Consistent with the requirements of the WH&S regulations; in determining the appropriate resourcing for the event including placement of traffic controllers in accordance with the approved Traffic Guidance Scheme, the event controller (or traffic control supervisor) must consider a traffic controllers age, experience and level of competence to complete any tasks assigned as well as ensure that the extent of information, instruction and training provided to all traffic control resources is appropriate to complete their tasks safely.

Media

There will be publicity about the event with our associated supporters and partners including Shoalhaven City Council. 14 days prior to the event road closure information will be posted to all of Elite Energy's social media relating to the event, as well as Elite Energy's website with maps of closures and detours.

On-road Event Infrastructure

Ambulances

Emergency access lanes have been provided to allow emergency access to road closures areas.

Medical

There are medical personnel onsite for the duration of the event, at Callala Beach Community Hall, Quay Road.

Port-A-Loos

There will be an appropriate number of port-a-loos and 2 accessible toilets in Callala Beach Community Hall, Quay Road.

Cleaning/removal/disposal

There will be wheelie bins and skips positioned at various locations at the festival site. During the event there will be waste staff servicing the festival area of rubbish.

Barricades

Road closure barriers will be installed by Accredited Traffic Controllers.

Public Transport Management

All public transport services to the are will be notified prior to the event.

Volunteers and Event Marshals

Volunteer and Event Marshals are given a verbal induction on arrival, provided with Hi-Vis vest and contacts of event staff and medical. Volunteers and Event Marshals are placed on the course by the staff member in charge with specific instructions on what their role involves in the position. Communications between volunteers and staff will be done throughout the day.

Event Signage

Advanced notification and event signage per legislative requirements will be placed at key entry points to the affected area.

A letterbox drop to all affected residences and businesses will be carried out.

Variable Message Signs

Part 4 of this document details the VMS Strategy that will be deployed to inform motorists of changed traffic conditions approaching Forest Road on the Princes Highway in both North and South directions and along Callala Beach Road.

Access – Local Residents, Business, Emergency vehicles

Local Resident and Business Access

Residents and businesses in and around Callala Beach, Callala Bay, Myola and residents and businesses on Forest Rd will receive a letterbox drop notice with a minimum 14 days' notice, with road closures and alternate routes outlined. All access for residents will be maintained throughout the day when it is safe to do so.

Emergency Vehicle Access

The road closures allow for emergency vehicle access. NSW Ambulance, Police and Fire Brigade will be informed of changed conditions by Elite Energy.

Parking

As there is no public carpark located in Callala Beach, competitors and spectators are advised to park in surrounding streets, ensuring they are not blocking driveways and they do not park illegally on corners.

Many participants will be staying at local accommodation, such as Air BnB's, Tasman Holiday Park at Myola and Beach and Bay Stay Motel, located next to Club Callala.

Staff are advised to park on Quay Rd, as they will be onsite before the road closure takes place.

'Special Event No Parking – **Saturday 13th December 2025** 6am-2pm' signage to be installed on King George Street (see TGS-CBTF-2023 Plan 16) on Friday 12th December.

Reason for Report:

The reason for this report is to seek Shoalhaven Traffic Committee approval for the proposed regulatory signage associated with the development (SF10965) at Lot 763 DP 1224932, Hitchcocks Lane, Berry (Stage 1) as per Plan No. D25/191591.

Recommendation

That:

1. The Chief Executive Officer (Director City Services) be advised that the Shoalhaven Traffic Committee has no objection to the proposed regulatory signage associated with the development (SF10965) at Lot 763 DP 1224932, Hitchcocks Lane, Berry (Stage 1) per development consent condition(s) 19, and per Plan No. D25/191591.
2. The recommendation be approved by the Director City Services under delegated authority from Shoalhaven City Council - refer MIN21.411

Background:

APPLICANT: Maker Eng Pty Ltd

OWNER: New Horizon Properties

Hitchcocks Lane, Berry - Lot 763 DP 1224932 – Regulatory Signage (Stage 1) - 119 lot Sub-Division.

As part of SF10965, Traffic Committee endorsement is being sought for the proposed regulatory signage at Hitchcocks Lane, Berry.

As outlined in Condition(s) 19 of the condition of consent, the following is required:

19. Laneway – Design Standards

Before issue of a Subdivision Works Certificate, certified road design engineering plans for the laneway between Proposed Road 01 and Hitchcocks Lane must be prepared by a professional engineer, (as defined in the National Construction Code) or surveyor and approved by the Certifier. The road design must comply with the following:

- a. Council's Engineering Design Specifications sections D1– Geometric Road Design and D2 – Flexible Pavement Design.

b. AUSTRROADS Design Requirements and Specifications.

c. The Preliminary Roads and Drainage Layout Plans Sheet 01 to 05, Ref. No: N25424-402 to N25424-406, Rev. P9A, prepared by Allen Price and Scarratts on 15/11/2024, except that:

- i) Design vehicle to be a 14.5m long rigid bus and must be widened to accommodate the required turning manoeuvres.*
- ii) Central dish drain or layback kerb and gutter with grated pits to be provided in accordance with Council's Standard Drawings.*
- iii) N/A*
- iv) Additional signage provided on the eastbound approach on Hitchcocks Lane to prevent access into the laneway except for emergency vehicles.*
- v) Laneway must have thresholds constructed of stamped, coloured or patterned concrete. Pavers or other alternatives are not to be accepted for use within the road carriageway unless accepted by Council and demonstrated by the designer that the pavement treatment will have similar durability and longevity to concrete treatment and result in similar maintenance requirements.*

d. Subsoil drainage behind the kerb line on the high side of the road or both side if the cross fall is neutral or the road is in cut.

Details of Submission:

This proposal involves the installation of the following regulatory signage, as per Condition (s) 19 of the conditions of consent,

- 'No Stopping' (R5-400(L)) twenty three metres from the intersection of Hitchcocks Lane and Laneway 01.
- 'No Left Turn' (R2-6n(L)) and 'Authorised Vehicles Excepted' (R9-4) at the intersection of Hitchcocks Lane and Laneway 01.
- 'No Right Turn' (R2-6n(R)) and 'Authorised Vehicles Excepted' (R9-4) at the intersection of Hitchcocks Lane and Laneway 01.
- A temporary 'Obstruction Maker' (D4-5-1) at the intersection of Hitchcocks Lane and Laneway 01 until the future stage is constructed.

Consultation:

The Development Application (SF10965) was on Public Exhibition in accordance with Council policies, initially between 26 October 2022 and 9 November 2022. A further consultation period was undertaken between 17 November 2022 and 1 December 2022, which was then extended to the 1 February 2023. No submissions regarding the proposed signage were received. The development application was approved on the 6 December 2024 by order of the Land and Environment Court.

Risk Implications:

The proposed measures aim to provide safe traffic management, including swept path turning area for the intersection of Hitchcocks Lane and the proposed lane. Furthermore, the works are stipulated in a valid development consent. Undue prevention of, delay to, or alteration to the completion of requirements of the consent may expose Council to legal action.

Financial Implications:

The implementation of this proposal will be funded by the private developer and there will be no financial implications to Council. However, Council will be responsible for the ongoing maintenance of these assets.


