PRESENTATIONS

YA25.5 Update - Shoalhaven Affordable Housing Strategy - Strategy Planning Team

Kristy O'Sullivan – Strategic Planner, Strategy Planning Team – presented to the Committee on the recently adopted Shoalhaven Affordable Housing Strategy (AHS).

The presentation provided an overview of the "housing spectrum", and the roles and responsibilities of service providers and government agencies in helping to address the housing affordability challenge.

The presentation also provided an overview of the AHS, including its purpose, the public exhibition



process and outcomes, and finalisation of the document. The Committee was also provided with an overview of the next steps towards implementing the AHS, including programming work on the short-term Actions and the establishment of a Council-led Affordable Housing Action Taskforce.

Following the presentation, there was a general discussion about land-use planning in Shoalhaven, including redevelopment opportunities along the Nowra Riverfront and the work involved in planning new urban release areas. Matthew Rose – Coordinator, Strategy Planning Team – also provided an overview of Council's online demographic tools (Community Profile, Social Atlas, Population Forecast, Economic Profile and Housing Monitor), which can be accessed online at: https://profile.id.com.au/shoalhaven/

YA25.7 Workshop - Disability Inclusion Action Plan

Under the NSW Disability Inclusion Act 2014, Councils are required to review their Disability Inclusion Action Plan (DIAP) every four years. As part of this requirement, Councils must consult with specific groups in the community including Aboriginal and Torres Strait Islander, people with a disability and young people. Council's advisory committees provide a great opportunity for such consultation in addition to other engagement that is being conducted in the broader community.

Staff presented an introduction to the work being done to review the current DIAP. The meeting discussed Council's actions under the current DIAP and possible future disability inclusion initiatives.
