SB19.25 Shoalhaven Sports Board - Current Projects Update

HPERM Ref: D19/283569

The Board discussed the report and commented on the following items. The Chair acknowledged it was an informative report and thanked the staff.

The Chair asked about the use of the old North Nowra tip site for cycling. Staff and members noted the challenges with the site.

The Chair asked about the new online booking system. Staff noted that it is 85% functional and close to being complete for Stage 1, Council managed facilities.

It was noted that work to the value of \$2 million was being done at Nowra Showground, comprised of Government grant funding in addition to Council funding.

Staff noted that sporting groups can apply for Club Grants directly. Council can assist with letters of support to clubs applying for grants. If works are on Council land a letter of owner's consent is usually required with the funding application.

Members raised the issue of dog excrement on fields, particularly at Nowra Showground. Staff acknowledged the problem and that a number of complaints had been raised by sporting groups about the condition of the field. Stickers have been put on bins and Rangers are undertaking additional patrols. There are plans to provide bags for waste at the Showground.

Council has made grant applications to seal the Shoalhaven Heads Pump Track. The track is open and being used.

Members asked how many people play baseball due to the amount of funds invested in facility. Members and staff noted that it is a growing sport. Staff noted that the funds were from grant funding and Council have only contributed funds towards amenities.

Grant funding for lighting for Huskisson Football Association has been applied for. Members asked for the amount applied for to be circulated. The grant amount is \$111,000.

Staff noted that the Special Rate Variation funding for sportsgrounds has been allocated.

The Chair asked members to email ideas to staff for a Sports Board banner and brochure.

SB19.26 Sports Grants Program 2019/2020 - Funding

HPERM Ref: D19/288758

Members noted the difficulty for clubs applying for funds to raise funds for matching funds for grants. Staff advised that clubs can provide resources in kind as an alternative to cash and that Council can assist clubs with their applications. Clr Wells suggested re-consideration of the guidelines for the grants prior to re-advertising the program, such as not requiring matching funding up to an amount of \$3,000. Susan Edwards noted that the community grants have recently been reviewed too.

The Board discussed whether to make changes to grants guidelines prior to re-advertising the program to seek grants to allocate unspent funds. It was proposed to incorporate a change to the criteria to accept applications for smaller applications without requiring matching funding where insufficient applications are received. Members suggested that Council approves a change to the Guidelines to allow applications for grants up to an amount of \$3,000 for equipment without requiring matching funding.

Members asked about clubs applying more than once. Staff acknowledged repeat applicants and noted that for other grants programs there are guidelines to prevent applicants in successive years.

The Board discussed communication and promotion with clubs. Jane Lewis noted that communication is better than ever and welcomed feedback on how it can be improved further. It was acknowledged that turnover with club executives make it difficult. However, clubs now normally have a generic email address and a website or Facebook page, making things better. Jane advised that there is now a marketing and digital media position within team which is anticipated will improve communication with clubs. The new website has been launched for Shoalhaven Swim & Fitness. Jane encouraged Board members to spread the word.

Kevin Norwood spoke about the benefits of the Zipporah online booking system. Jane Lewis suggested that the Board consider a Survey Monkey survey for feedback from Sports Workshops to improve our communication and seek feedback to assist with future planning and content of workshops.

PURPOSE

The Shoalhaven Sports Board (Board) is to provide advocacy for the sporting community on policy, direction and strategic planning related to Council's objectives. To achieve this policy and strategic objective, the Board will be strategic in nature and focus on appointments to achieve this outcome.

2. STATEMENT

Council encourages and recognises the value of community participation in guiding the strategic development of both sport facilities and participation within the Shoalhaven Local Government Area. To guide sports development each Board member will be responsible for maintaining and reporting on a specific portfolio.

3. TERMS OF REFERENCE

3.1. RELATIONSHIP TO COUNCIL

The Shoalhaven Sports Board is a strategic advisory committee to advocate for and inform Council's decision making processes related to improving Shoalhaven sporting facilities and sports participation.

3.2. ROLE OF THE SHOALHAVEN SPORTS BOARD

- Represent the whole Shoalhaven Sporting Community (all sports)
- Provide ongoing, high level policy and planning advice to Council.
- · Make recommendations to the Council on all relevant business presented before it
- · Advocate and maintain specific sports related portfolios.
- · Advocate and promote Board recommendations.

3.3. MEMBERSHIP

Board membership is to have a range of strategic capability, expertise and advice to cover specific sports related portfolios.

The Board will have a total membership consisting of the following:



Shoalhaven City Council - Shoalhaven Sports Board - Terms of Reference

- Eleven (11) local community members (includes 2 positions from disadvantaged sporting groups).
- All Councillors.
- General Manager (or nominee)

In addition a member of NSW Sport & Recreation will be invited to attend Board meetings but will have no voting privilege.

The Sports Board be delegated authority to invite representative from disadvantaged sporting groups to inform the Board.

3.4. COMMUNITY MEMBER APPOINTMENTS

- Nominations should be advertised throughout the community.
- Appointments to the Board will be for a four (4) year term with a set commencement and finish date.
- There is no limit on the number of terms a community member may serve.
- Community members may re-apply for nomination at the conclusion of their Term.
- Vacancies will be advertised locally via media and Council communication networks.
- · Council will manage the application process.
- An interview panel consisting of a Council staff member, the Chairperson of the Board and one (1) suitably qualified independent representative will assess the applications and make recommendations for appointments to the Board.

3.5. TERM OF OFFICE

- Community membership will be renewed every 4 years and ideally during the midterm of the elected Council.
- Councillor membership will be renewed at following normal Council elections.
- Should there be a casual Community membership vacancy it may be filled upon the resignation of a Community member and will align with set fixed finish dates.

3.7. MEETING PRACTICES AND PROCEDURES

- The administrative provisions of Council's adopted Code of Meeting shall apply subject to any amendment by this Terms of Reference.
- The chairperson will be appointed by the Board, the position will be limited to a two (2) year term and be open to all members.
- Each Board meeting shall be properly recorded by the taking of minutes by Governance
 Unit
- The minutes of the Board meeting will be submitted to the next available Council Meeting.
- The quorum for each meeting will be seven (7) members of the Board.
- If a quorum is not present within 30 minutes of the time appointed for the commencement of the Board meeting, the meeting shall lapse.
- In the event of a tied vote, the Chair can exercise a casting vote.
- · Formal Board meetings will be held quarterly.
- Agenda and minutes from previous Board meetings will be circulated to members at least seven (7) days prior to the meeting.
- Board members must declare in writing any interest in any report tabled at the meeting covered by the Code of Conduct and Pecuniary Interest.
- Informal Board meetings, special meetings that may discuss specific portfolio matters will be held as and when required or set by the Board
- Planning and costs associated with conducting meetings will be borne by Council.
- Board recommendations which are determined to be purely or substantially 'operational' in nature, will be dealt with by the relevant council officer and any action or lack thereof reported to the Board.

3.8. CODE OF CONDUCT

- All members of the Board are required to observe the provisions of the Council's Code of Conduct.
- Board members should act in a professional and responsible manner with the information they obtain as a member, as the Board require openness and honesty to function well.
- Board members should feel free to express their opinions and views without fear of recrimination.
- It is essential for Board members to accept collective responsibility, and remain loyal to
 decisions of the Board, even where they may not have agreed with the final decision.

3.9. CONFIDENTIALITY AND PRIVACY

Members may have contact with confidential or personal information retained by Council. If so, members are required to maintain the security of any confidential or personal information and not access, use or remove any information, unless the member is authorised to do so.

3.10. COMMUNICATION

- Members of the Board are not permitted to speak to the media as Committee of Council representatives of the Board unless approved by the Chairperson.
- Where approval has been given by the Chairperson, views and opinions expressed are those of the Board and not of Shoalhaven City Council.
- Where endorsement is required from Shoalhaven City Council, approval must be sought through the formal processes.
- The Chair of the Board is the point of contact for communication between Board members and Council staff.

3.11. COUNCIL STAFF ATTENDANCE

Executive Council staff are normally required to attend the meetings of the Board. Other staff at the relevant Group Directors' discretion or at the Board's request can attend meetings as required. Staff have no voting privileges.

Council will provide secretarial support to arrange meetings and take minutes and provide professional office support where required.

3.12. EXPECTATIONS OF BOARD MEMBERS

Reason for Report

Report to the Sports Board on Council's approach to determine a listing of potential projects to be funded from the Special Rate Variation (SRV) and other sports ground projects for delivery over the coming years.

Recommendation (Item to be determined under delegated authority)

That Sports Board receive this report on Council's approach to community consultation to identify potential projects for the next 5 years.

Options

1. That Sports Board receive this report on Council's approach to community consultation to identify potential projects for the next 5 years.

<u>Implications</u>: This will keep the Sports Board informed of our approach and give them the opportunity to advocate to our sporting associations to be part of the program for delivery of upgrades, improvements and embellishments to the Shoalhaven's sports grounds.

Background - SRV Funding

Sports Board members will recall that Council resolved to fund, through allocation of Special Rate Variation (SRV) monies, \$500,000 each year for the upgrade of playing surfaces at our sportsgrounds in the Shoalhaven.

MIN17.925 That Council:

- 1. Abandon any consideration of the imposition sporting field user fees and the General Manager be requested not place this on the Agenda for the term of this council
- 2. Include from the rates increase \$500,000pa to the upgrade of our sporting fields

This resolution provided \$500,000 annually + CPI for upgrades and improvements to sportsgrounds playing surfaces in the Shoalhaven.

A Community Approach to Future Asset Management Plans

Council staff have developed and maintain a list of sports grounds improvement requests. This current list includes projects identified by clubs, state sports bodies, local sporting organisations, Council staff, the Community Infrastructure Strategic Plan, and from soil testing reports etc. It should be noted that the list of projects is varied, and has not been intended at this stage to be 'all inclusive'. See Attachment 1.



In the 19/20 financial year, the SRV allocation of funding was spent specifically on projects identified in this list, and regular updates are reported and provided to the Sports Board through the quarterly meetings. It is important to note that SRV funding relates only to the upgrade of sporting fields, so items that meet the SRV funding are identified in green in the attachment.

It is recognised that this compiled list of projects is not 'all inclusive' and needs further development (with inclusion of amenities, buildings etc). This will be a useful resource to inform Council's Asset Management Plans, provide options for grant funding opportunities, and enable a longer-term strategy for delivery of sportsgrounds upgrades, embellishments and improvements. It can also continue to be used to identify projects to be funded from the SRV funding.

To involve our sporting clubs and associations, Council are proposing to write to our sporting associations, Office of Sports, the Sports Board and clubs, requesting them to identify key projects and identified works from their strategic plans for the next five years. These will then be collated and the current list updated, so that projects can be prioritised accordingly and reported to Council for endorsement.

The consultation with sports organisations will happen over the next couple of months, ready to be reported to Council's Strategy and Assets Committee in the first quarter of the new year. It is proposed that in our communications to the sporting bodies, Council will clearly articulate the SRV funding is for sportsground surface field upgrades only, but also request to be informed about projects identified to improve, embellish and enhance our sporting grounds (this will including tennis, netball, etc).

Council would appreciate the Sports Board sharing this information with their contacts and advocating for our sporting associations to be part of this process. Council staff will forward all the necessary information and links when they are developed.

Community Engagement

Council will develop a Communication Strategy with our Communications team to go to our Sporting Associations, the Sports Board, Office of Sports. This will include a 'Get Involved' page on Council's website, along with letters and Facebook feeds.

Policy Implications

The information gathered through this consultation will assist with the development of Council's Asset Management plans, updates to the Community Infrastructure Strategic Plan, Council's Delivery and Operational Plans and our financial planning.
