The Shoalhaven Traffic Committee is a technical review committee, not a committee of Council under the Local Government Act 1993. The Roads and Maritime Services (RMS) has delegated certain powers to Council under the Transport Administration Act 1988 (Section 50). A condition of this delegation is that Council must take into account the Traffic Committee recommendations.

There are four formal members of the Traffic Committee, each of whom has a single vote only. The members are representatives from:

- NSW Police Force
- RMS
- Shoalhaven City Council
- Local State Member of Parliament (for the location of the issue to be voted upon)

If the RMS or NSW Police Force disagrees with any Traffic Committee recommendation, or Council's resolution (on any Traffic Committee recommendation), they may lodge an appeal with the Regional Traffic Committee for determination. The appeal must be lodged in writing within 14 days of the date of notification in writing. Any action relative to any issue under appeal must cease until the matter is determined. The Regional Traffic Committee is chaired by an independent chairperson and submissions and representations are welcomed from all interested parties.

Council cannot amend a Traffic Committee recommendation. The Council can only: adopt the Traffic Committee recommendation; not adopt the Traffic Committee recommendation, or request the Traffic Committee reconsider the issue.

### Recommendation

### Background:

Council has received funding from the NSW Government Safer Roads program for Road Safety Improvements at the intersection of Elizabeth Drive and Berry Street, Vincentia. The funding is for design and construction in the 20/21 financial year.

### **Details of Submission:**

The project aims to improve the intersection of Elizabeth Drive and Berry Street, Vincentia. This originally involved the design and installation of a single lane roundabout, including all traffic calming, linemarking, lighting, and signage. Pedestrian refuges (splitter islands) were also to be provided on both legs of Elizabeth Drive with painted splitter islands on both legs of Berry Street.

Following this, the construction of a Shared User Path (SUP) along Berry Street was also considered, to complete the missing link between the Bayswood Subdivision and Collingwood Beach, and would include all associated path connections and kerb ramps at the intersection.

Originally, the project was designed in two (2) stages:

STAGE ONE: Kerb & gutter, kerb ramps, pedestrian refuges, linemarking, lighting and signage.

STAGE TWO: The roundabout treatment originally nominated as outlined above, incorporating all the elements constructed as part of Stage One, with minor changes to linemarking and signage to suit the different intersection treatment.

However, following consultation with the community (discussed further below), Council is seeking a variation in the funding to design and construct only Stage One (i.e. the splitter islands) due to the roundabout not being supported.

A signage and linemarking plan, including both Stages One and Two, has been submitted for the Committee's consideration.

#### Consultation:

Following initial consultation with the community, after the project was nominated in 2019, it was noted that the proposed roundabout was not fully supported by respondents. However,



the need to provide safe crossing points for pedestrians at this location remained outstanding. As a result, and supported by a new road safety audit, Council had provided residents with a revised proposal for a shared user path along Berry St, with pedestrian refuges on both legs of Elizabeth Drive, to enable safer and improved pedestrian connectivity to the Round the Bay Walk.

Council recommenced this consultation with affected residents and the Vincentia Ratepayers and Residents Association in December 2020. To date, Council has received five submissions, three in favour and two against. The two dissenting submissions had raised concerns regarding vehicle manoeuvrability around the refuges and perceived increases in traffic noise.

### **Risk Implications:**

This proposal will improve road safety at this location and will satisfy the conditions for the Safer Roads grant funding. However, the degree of road safety provided from Stage One will not be to the same degree without Stage Two, as identified from the findings of two independent Road Safety Audits. No further are risks associated with this proposal.

### **Financial Implications:**

This proposal will be funded by the Safer Roads Grant Funding provided to Council by the NSW Government.
