The Shoalhaven Traffic Committee is a technical review committee, not a committee of Council under the Local Government Act 1993. The Roads and Maritime Services (RMS) has delegated certain powers to Council under the Transport Administration Act 1988 (Section 50). A condition of this delegation is that Council must take into account the Traffic Committee recommendations.

There are four formal members of the Traffic Committee, *each of whom has a single vote only*. The members are representatives from:

- NSW Police Force
- RMS
- Shoalhaven City Council
- Local State Member of Parliament (for the location of the issue to be voted upon)

If the RMS or NSW Police Force disagrees with any Traffic Committee recommendation, or Council's resolution (on any Traffic Committee recommendation), they may lodge an appeal with the Regional Traffic Committee for determination. The appeal must be lodged in writing within 14 days of the date of notification in writing. Any action relative to any issue under appeal must cease until the matter is determined. The Regional Traffic Committee is chaired by an independent chairperson and submissions and representations are welcomed from all interested parties.

Council cannot amend a Traffic Committee recommendation. The Council can only: adopt the Traffic Committee recommendation; not adopt the Traffic Committee recommendation, or request the Traffic Committee reconsider the issue.

GENERAL BUSINESS**Bomaderry - Princes Highway South Bound**

- Sgt Kelly Thomas noted that the 70km speed limit signs on the approach to Bomaderry should be increased in size for visibility.
- Ms Nicole Brodie – TfNSW – confirmed that the 'B' size signs will be changed to 'C' size signs.
- Sgt Simon Pugh also noted that the South bound lane is of concern to Police because of the large vehicle traffic combined with people exiting the aged care facility into traffic.

Linemarking, Stop Signs and Potholes

- Sgt Kelly Thomas noted that, with linemarking is wearing out, and stop signs set too far back from intersections, it is difficult to enforce some stop signs. Examples include Hyam Street, Worrigee Road, Greenwell Pt Rd and Isa Road intersections.
- Mr David Pieresko – Senior Engineer – advised that these would be reported to the relevant District Engineer for their attention and for NSW Police to continue to report these to Council for remediation.

Buses Zones & New Subdivisions

- Sgt Kelly Thomas advised that Police had received complaints from residents about buses in new subdivisions, that nature and median strips are being damaged by buses manoeuvring.
- Ms Simone King - Premier Motor Service – advised that they are happy to receive any feedback about bus routes, and that bus companies are required to follow guidelines under contracts.
- Ms Simone King - Premier Motor Service – on behalf of bus operators, enquired whether it is possible to review the Bus zone on Mattes Way, Bomaderry, as there is currently some conflict with the No Stopping and Bus zone for the River College.
- Ms Nicole Brodie – TfNSW - Confirmed that the bus zone is currently within the no stopping zone. TfNSW will make it a priority to include “Buses excepted 1 minute” signage.

RBT Zone in South Nowra Truck Bay

- Sgt Kelly Thomas advised that Police use the southern end of truck bay in South Nowra for RBT, but there is currently no ‘Buses and Emergency vehicles only zone’ signage.
- Ms Nicole Brodie – TfNSW – will refer this matter to Mark Wolstenholme for liaison between TfNSW, Premier Motor Service, and NSW Police.

Princes Highway, Corks Lane Milton Speed Limit

- Ms Nicole Brodie – TfNSW – advised that TfNSW has previously consulted Police and Council regarding changing the existing speed limit on Corks Lane in Milton. TfNSW will forward a new proposal extending the 50km/hr zone to Police and the relevant Council staff for further consultation.

Agars Lane Berry

- Cllr Patricia White advised that, due to the overflowing of Coomonderry Swamp, drivers are hazardously stopping on Agars Ln in Berry (an 80km/hr zone), to get wildlife off the road.
- Ms Nicole Brodie – TfNSW – advised the best solution to this would be to submit a request for a temporary speed reduction, as well as a request for “Wildlife” signage, to Council.

Other

- Sgt Kelly Thomas requested copies of temporary speed zone changes be provided by Council to assist with Police enforcement of temporary speed limits.
- An Extra Ordinary Meeting will need to be held as soon as possible to discuss Traffic Management Plan for Aboriginal Knockout event.
- The upcoming Elite Energy events which are held in Huskisson and Callala later in the year will also require Traffic Management plans.

As per Condition 29 of development consent DA22/1057, the following is required:

Condition 29.

Prior to the issue of a Construction Certificate, certified road design engineering plans must be prepared by a suitably qualified engineer or surveyor and approved by Council. The road design must comply with the following:

- d) *A basic right (BAR) turn treatment is to be designed and constructed at the development site's access compliant with the requirements of AUSTRROADS Guide to Road Design (2021). The design must ensure that:*
 - i) *the minimum setback/clear zone to structures is provided (i.e. to the power poles and street signs/lights within Plunkett Street)*
- e) *'Keep Clear' line marking must be provided at the development site's access compliant with relevant Australian Standards.*

A signage and line marking plan has been submitted to the Committee for consideration.

Consultation:

This Development Application had been on Public Exhibition between 03/02/2022 and 19/02/2022 with feedback requested from the community, directly affected residents and local community consultative body. During this period, Council had received no submissions.

Council's Planning and Development Services Team approved this development on the 3rd of August 2022.

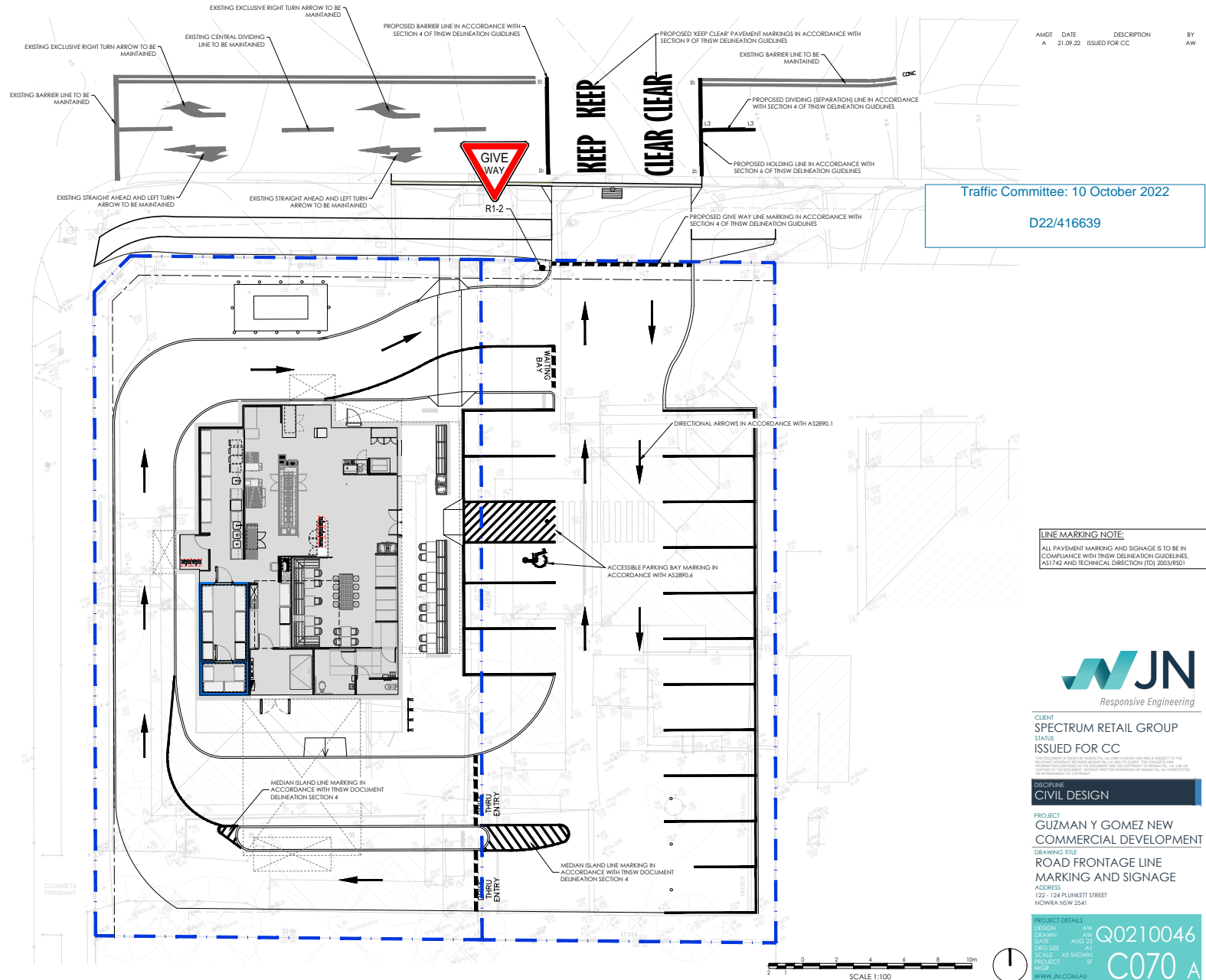

Risk Implications:

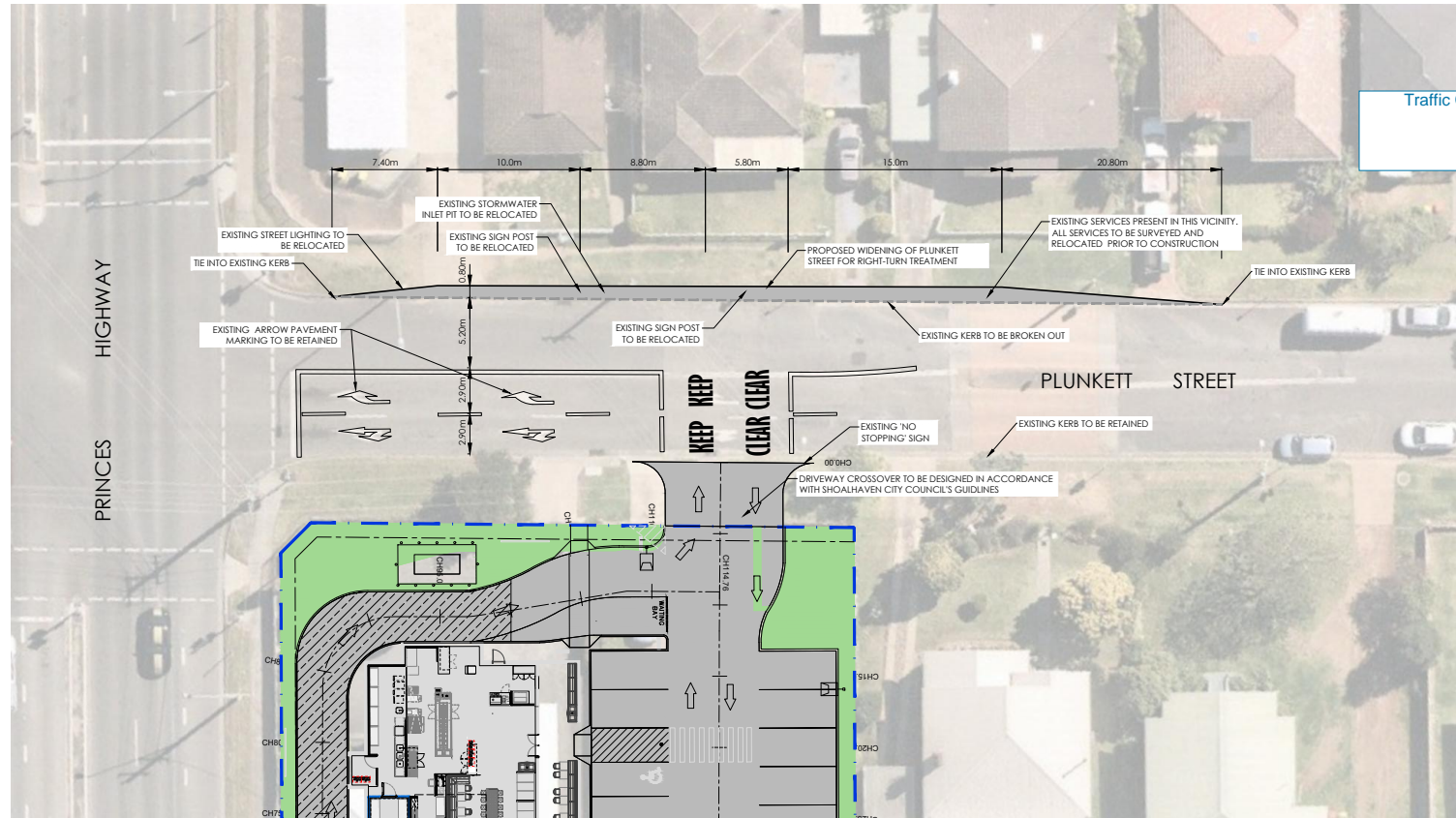
