CCL23.9 Exemption to Tendering - Stormwater Pipe Renewal - HPERM Ref: Scott Street Shoalhaven Heads D23/99082

RESOLVED

That Council

- Endorses the decision to continue to use the current contractor (CBK Constructions Pty Ltd) for the urgent rectification work and approves an exemption from tendering in accordance with Section 55(3)(i) of the Local Government Act 1993, for the renewal of the stormwater pipe drainage system alongside properties fronting Scott St Shoalhaven Heads, noting that a satisfactory result would not necessarily be achieved by inviting tenders due to <u>extenuating</u> <u>circumstances</u> noting that:
 - a. Sink holes have been occurring and growing larger above and adjacent to the existing large diameter stormwater pipes and there is an urgent need to continue to address the damage;
 - b. It is crucial to address immediately to prevent further deterioration of the ground and potential damage to public and private infrastructure;
 - c. The current methodology involving isolated repairs is proving to be slow, costly and inadequate. A change to the methodology is required.
 - d. The current contractor (CBK Constructions Pty Ltd) undertaking the current repairs have become experienced with the local ground and groundwater conditions;
 - e. CBK Constructions Pty Ltd have become familiar with the risks and constraints affecting the project and have worked with Council in implementing risk management practices (vibration monitoring, ground water monitoring, house movement monitoring and dilapidation reporting);
 - f. CBK Constructions Pty Ltd have assisted the design consultant and council in developing the new design;
 - g. Council is receiving numerous complaints about the delays in progressing the work;
 - h. Residents have become increasingly frustrated with the duration of the repair work and now again with the planned change in approach to the rectification work.
 - i. Direct appointment will save another 6 weeks of preparing, calling, assessing and reporting on tenders, as well as the risk of many more weeks of delay in site establishment and familiarisation if another contractor was introduced.
- 2. Authorises the CEO (Director City Services) to negotiate and enter into a new contract with CBK Constructions Pty Ltd for the repair of the stormwater pipe renewal.
- 3. Advise the Office of Local Government of Council's decision in respect of the use of the s55(3)(i) exemption in this matter.
